	<ul style="list-style-type: none"> • set-up their Brain in Hand software • input their strategies so they are available when they need them the most • use Brain in Hand collaboratively with their supporters. <p>In addition, Regional Engagement Specialists will have a key area of responsibility within the customer engagement process; providing both proactive and responsive user caseload management support to the business in relation to our Brain in Hand customers at delivery settings (primarily universities) within their region.</p>
